Sub: - Krishna University – Directorate of Admissions - KRUCET-2017
Admissions - Filling up of unfilled seats in spot admissions - Reg.

I am by direction to inform you that the 1st, 2nd, 3rd and 4th Phases of Counseling for admission into various PG courses offered in KRU Campus and affiliated colleges have been completed and the tentative vacancy position in various courses were send to your college mails. In this regard kindly note the following points.

1. The unfilled seats and the management seats in each course offered can be filled by the concerned college during 31st July to 5th August, 2017 conforming to the guidelines. Such seats shall be ratified by the Directorate of Admissions, KRU at its office from 7th August to 10th August 2017.

Please Note: The Spot admission is only to the Candidates who are not admitted in any course in any College / University.

2. **The Director, DOA is not responsible for any court cases regarding the admissions in affiliated colleges, such as discontinuity of courses, cancellation of admissions, fee refund, any kind of violation in admission, etc.**

Guidelines for filling-up of unfilled seats in affiliated colleges through KRUCET - 2017:

1. (a) 50% in the qualifying examination is the minimum required percentage for BC & OC candidates (45% for SC/ST candidates) for admission into science courses.
(b) A pass in the qualifying examination is sufficient for admission into Arts & Commerce courses. The requirement for M.Ed. Course is a pass with a minimum aggregate of 50% marks for BC, OC and others (45% for SC/ST candidates).
(c) Candidates passed in instant examinations of 2017 are also eligible for admission.
2. Candidates should fulfill the eligibility criteria for the subject as specified in KRUCET brochure - 2017.
3. Candidates have to pay Registration fee Rs.400/- (For SC&ST Candidates – Rs. 300/-) along with Counseling fee Rs.1500 as DOA processing fee.
4. The candidates who had paid Registration fee & counseling fee earlier are


exempted to pay this fee.

5. Two separate DD's should be taken for payment towards CDC fee and DOA processing fee drawn in favor of **KRUCET-2017, KRISHNA UNIVERSITY payable at Machilipatnam.**
6. The students admitted under Management Quota of seats or through spot Admissions i.e. left over seats of the Convener / Director quota filled by the Management in the Institutional spot admissions will not be eligible for Post Metric Scholarship scheme (vide GO.No.66 SN.Edn, Department dated. 8/9/2010).
7. The candidates should be insisted upon to produce all the original certificates, before getting admission, and one set of Photo copies should be submitted at the time of ratification with Principal's signature. Any deviation made in this regard will be viewed seriously and such admissions will not be ratified under any circumstances.
8. The College under management quota should admit only those students with or without Rank in the KRUCET-2017 with required eligibility criteria as per information brochure.
9. Managements are required to follow the procedure given above in filling the vacant seats. The model proforma to be submitted after the institutional spot admissions and management seats made is enclosed herewith for ready reference (Annexure-I). The details of spot and management admissions made are to be neatly typed in the proforma and sent to the Director through special messenger for ratification on the said date according to the schedule positively.

Note:

1. Candidates have to pay Registration fee Rs.400 /-(For SC&ST Candidates – Rs. 300/-) + Counseling fee Rs.1500 as DOA processing fee.
2. Candidates who want to get Admission through spot admissions in Management quota are needed to pay 50% of the total fee of opted courses.
3. The Principals are requested to depute one of the staff members with Identity card duly signed by the college authorities who comes for the collection of the list of candidates admitted and their original certificates from the Director, KRUCET-2017 as per the schedule given and the Director will not be responsible for any future problems in this regard. The Principals are requested to stick to the above mentioned dates in collecting the applications and list of admitted candidates into their respective colleges.
